- Hereby releases, waives, discharges, and covenants not to sue MWR, or the promoters, participants, racing associations sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event(s), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation or loss control activities regarding the premises or event(s) and each of them their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees" from all liability to the undersigned his legal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore or account of injury to the person or property or resulting in death of the undersigned arising out of or related to the event(s), whether caused by any partial or sole negligence of the Releasees or otherwise.
- Hereby agrees to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to the event(s) whether caused by any partial or sole negligence of the Releasees or otherwise.

The undersigned agrees that all rights in such photographs, video productions and telecasts including, but not limited to, rights of sale, reproduction, use and distribution, shall belong to MWR and/or a MWR affiliate its successors or assign, which may make whatever use of such photographs video productions and telecasts as it or they may desire. The undersigned hereby grant to MWR and/or a MWR affiliate, its successors and assignees the non-exclusive right to use the undersigned's name or likeness for any and all commercial benefit and purpose, without limitation, in perpetuity, through the universe, in all media whether known or unknown.
